# Concept


A small multipurpose enclave is provided for staff and offers a quiet space for rest and rejuvenation when needed. This setting also encourages different postures during the day, and keeps clinicians engaged while taking their break by providing a quiet focus area for work if needed or desired.

- 1. Ottomans allow users to put their feet up and change their posture. They can also be used as a bench and support the "anxious waiter".
- 2. Convey integrates with V.I.A. modular wall to create spaces for focused work.
- 3. The mobile caddy utilizes the space beneath tabletops for easy organization and storage.

# Concept

A small multipurpose break room is provided for staff. This setting encourages different postures throughout the day, and keeps clinicians engaged while taking a break or having lunch. A kitchenette and personal storage is provided within the space.

# Concept


This smaller space is intended as a breakroom that supports small groups of individuals. This solution provides an open respite spot for relaxation as well as a banquette setting for nourishment.





- 2. Incorporating greenery into a respite space can help aid in reducing stress and anxiety for clinicians.


