Family members need an intuitive, welcoming and hosted environment to support activities of daily living as well as an environment that helps cue behaviors for them to productively partner with clinicians.

# Family presence + involvement is beneficial. Yet family needs are not fully supported in the patient room:

- Uncomfortable Sleeping + Resting
- Crowded Eating + Socializing
- No Space for Personal Items
- No Space for Teaching + Learning
- Challenging to Stay Connected to Work + Life Outside the Hospital

#### **Ways to Support Family Involvement**

- · Have a designated space
- Accommodate for frequent + inclusive communication
- · Facilitate a range of activities for daily living
- Offer choice + control for seated postures
- Optimize spatial efficiency + cleanability
- Support clinician requirements

# Concept

This patient room solution supports the primary user—the patient, while also accommodating the needs of the caregiver in a flexible, comfortable and integrated manner. One side of room supports the clinicians, while the other side of room is designed for patient and caregiver use. Guests have ample space to sit and place their personal belongings, creating a more comfortable and personable healthcare environment.

- Additional worksurface allows a dedicated space for family members to work, while also providing a place to set patient personal items.
- 2. Teaching and learning are essential components of the entire healthcare journey, requiring multiple ways of sharing and displaying information. A whiteboard, reserved for family, provides a place to place for
- questions or messages for staff. It's also ideal for communication during physician consultations.
- Pocket mobile cart allows for easy sharing of information and encourages collaboration and communication between clinician and patient.

- 1. The Opus overbed table is central to activity and interactions in the patient room. Positioned next to the patient bed, it provides a convenient, adjustable surface for meals and other tasks, in combination with a surface for clinician use.
- 2. A recliner in a patient room setting provides a comfortable place for patients to sit, while also representing the progression of healing.

One side of room supports the clinicians and includes storage, med prep and charting; the other side of room is designed for patient and caregiver use. Guests have ample space to sit and place their personal belongings, creating a more comfortable and personable healthcare environment.

- 1. The footwall in the patient room provides the patient with positive distraction, storage for personal and commonly used items, and access to information.
- 2. A whiteboard, reserved for family, provides a place to write questions or leave massages for staff; it's also ideal for quick sketches and notes during physician consultations.

- 3. A sleeper sofa offers a comfortable place in the room for a care partner to rest during the day or at night while visiting a patient.

- 1. Wall-suspended cabinets provide ample storage, while allowing cleaning to easily be done underneath the cabinets, which aids in infection control.
- 2. Visual access to information and space for personal items are important to help reduce patient anxiety.

Patient rooms are more than just a place for a bed and medical equipment. They are environments that must serve as a temporary home for patients to heal and family members to be supported, be a workspace for clinicians, and a destination for visitors. This patient room is a comfortable and healing setting for the patient, and accommodates the care partners' need for rest, work and being close to their loved one.

#### Details

- 1. The Pocket mobile cart allows work or technology to move where it is needed.
- 2. The Cura chair's passive flex frame encourages movement and accommodates subtle adjustments and nervous energy, while aiding in overall circulation.
- Upper storage provides space for necessary equipment and easy access to medical supplies when needed.

4. Biophilic images incorporate nature into this patient room setting and can help reduce patient stress and anxiety.





This patient room is an efficient space where clinicians can move around freely and engage effectively with the patient and care partners, creating the most value out of the time they spend in the room. Appropriate use of furniture supports the care partners in every way, offering a place to spend time with each other, rest, be productive, host other guests, and communicate with clinicians.

- Node chair

- 1. Surround sofa offers flexible seating options as well as a place for personal items up off the floor within the patient room. A mobile multi-use surface for care partners is a convenient place for note taking.
- 2. Opus offers patients and care partners choice and control by creating places that accommodate important personal items.
- 3. An integrated markerboard allows care partners and clinicians to make important notes, or to communicate with one another when someone is not in the room.

- 3. Calming artwork helps create a residential aesthetic in the space and can help reduce patient stress and anxiety.

# Concept

Shorter stays in patient rooms for low acuity patients are becoming more common. Having a private space to retreat to improves patient satisfaction. In this low acuity patient room there is seating for care partners, as well as the necessary medical equipment, and workspace for care partners.

- Node chair

- Universal storage

- 1. Embold seating provides a comfortable and easily cleanable seat for guests without sacrificing beauty, making a sometimes-sterile space feel more aesthetically pleasing.
- 2. Universal storage with a nonwoven fabric cushion top provides storage space for the patient's personal belongings, while also serving as overflow seating for visitors.
- 3. A handwashing sink placed within view of the room's entrance helps remind clinical staff and visitors to wash their hands each time they enter and leave the patient room, which aids in infection control.

- 1. Offering a space for care partners to be able work, stay connected and charge their personal devices during a patient's stay plays an important role in the patient room.
- 2. A small table provides a location for personal items in the exam space.
- 3. A Sync unit placed outside of the patient room allows clinicians to easily keep an eye on the patient, without entering and disturbing the patient or their family.

# Concept

This patient room has been divided into three zones: the clinician zone, the family zone, and the patient zone. The clinician zone is strategically located near the entrance of the room to foster efficiency, while providing the least amount of disruption to the patient and family members. A small desk is placed in the family zone to provide a dedicated workspace to care partners, when needed.

#### Details

- 1. Secured to the wall, the Relay monitor arm offers a screen that can be easily adjusted. The monitor can be positioned so the clinician have a direct line of sight to the patient while charting, or it can be rotated toward the patient and care partner for teaching and learning in the space.
- 2. A Surround sofa offers flexible seating options as well as a place up off the floor for personal items within the patient room.

 An integrated markerboard allows care partners and clinicians to make important notes, or to communicate with one another when someone is not in the room.

# Concept

Making a mother comfortable as a patient is the top priority in this labor and delivery patient room layout. The clinician zone is tucked out of sight from the patient to provide less distracting and give a sense of privacy, while allowing the clinicians to still be close by for proper patient care. A labor tub is provided in the room to assist with pain relief during the early stages of labor.

#### Details

- Surround sofa offers flexible seating options as well as a place for personal items up off the floor within the patient room. Specified with a tablet arm, a mobile multi-use surface for care partners is a convenient place for a variety of functions.
- With supplies and utilities within easy reach, clinicians can focus on patient care while still providing a sense of privacy when needed during labor.

3. Artwork that incorporates nature can help reduce stress and anxiety for patients and care partners.

- 3. Calming artwork helps create a residential aesthetic in the space and can help reduce patient stress and anxiety.


